1 TRAVEL CANCELLATION INSURANCE
In the event that your travel is cancelled or delayed, we will reimburse the contractually agreed cancellation costs or, respectively, the additional expenses for the outbound journey. The deductible shall be equal to 20 % of the recoverable loss, subject to a minimum of EUR 25 per insured person.

3 TRAVEL HEALTH INSURANCE
If you need medical treatment while abroad, we will reimburse, among other things, the costs for out-patient and in-patient care as a private patient, prescription medications and dressings, and will assume the cost of a medically prescribed return transport home. All of that is covered with no deductible for you.

5 LUGGAGE INSURANCE
In the event that your baggage is damaged or lost, we will replace it for its current value up to 2,000.00 EUR. If your baggage is not delivered on time, we cover all necessary replacement purchases up to 500.00 EUR. All of that is covered with no deductible for you.

2 HOLIDAY GUARANTEE (TRAVEL CURTAILMENT INSURANCE)
In the event that you must curtail your travels, we will reimburse either the total amount or a partial amount of the travel price, depending on when your travel was interrupted. In addition, we bear the additional costs incurred in the case of a delayed return journey and refund unused travel services in the case of a delayed departure. Deductible: see travel cancellation insurance.

4 EMERGENCY INSURANCE
Our emergency service is available during your trip, 365 days of the year, around the clock and around the world. This includes, among other things, ambulance services or assistance in the event that you lose documents or means of payment. Our guardian angel will help you in the event that your property or car are damaged.
